- **17. March** Nomination packages are made available for those interested in running for a position in FASA, you may begin filling them out but the CRO will not be accepting applications until the day after.
- **18. March** The CRO begins accepting applications at 12:00 AM, and will continue to do so until 11:59 PM of 31. March. Please wait up until 11:59 PM of the day after your submission to hear back from the CRO confirming your submission or indicating any issues that need to be addressed. On the off chance that you do not receive a response regarding your application, please send a follow up email to <u>elections@fasaucalgary.ca</u>.
- **31. March** The deadline for submitting applications ends at 11:59 PM, after which the CRO will no longer be accepting new applications. If you have an application that was submitted to the deadline and not yet processed by the CRO, you will get a response within the next 24 hours. However, if any issues arise with your application, you will not be able to resubmit after the deadline. To avoid this, it is highly recommended that you submit your application as early as possible.
- **1. April** This day is reserved for the CRO to process applications that were submitted on 31. March, as well as confirm the list of candidates who will be running in the election.
- **2. April** Accepted candidates will be able to start campaigning, as well as create social media accounts to support their campaign. The CRO would like to remind all candidates that campaigning activities (in addition to creating social media accounts) prior to 2. April is *not allowed, and any evidence of doing so will result in sanctions and/or disqualification*.
- **10. April** The three day period for voting begins at 12:00 AM and continues until 11:59 PM of 12. April. Ballots can be submitted digitally via Google Forms, and from 10:00 AM to 4:00 PM of those days a voting booth will be set up in Science Theaters where devices will be provided for students who wish to vote in person. During this time candidates are still free to campaign *except in Science Theaters*.

13. April - Provisional results of the election will be announced by the CRO, although the

official confirmation of the results of the election will be made by FASA in the following days.

26. April - All campaign materials (posters, banners, etc.) are expected to be removed by the end

of this day. All social media accounts used by candidates for the express purpose of campaigning

are to be deleted or disabled by the end of this day. The CRO would like to remind all candidates

that failure to comply may result in sanctions and/or disqualification.
